## Is the World Heritage Status of the Wadden Sea Region well-known among tourism stakeholders in your area?

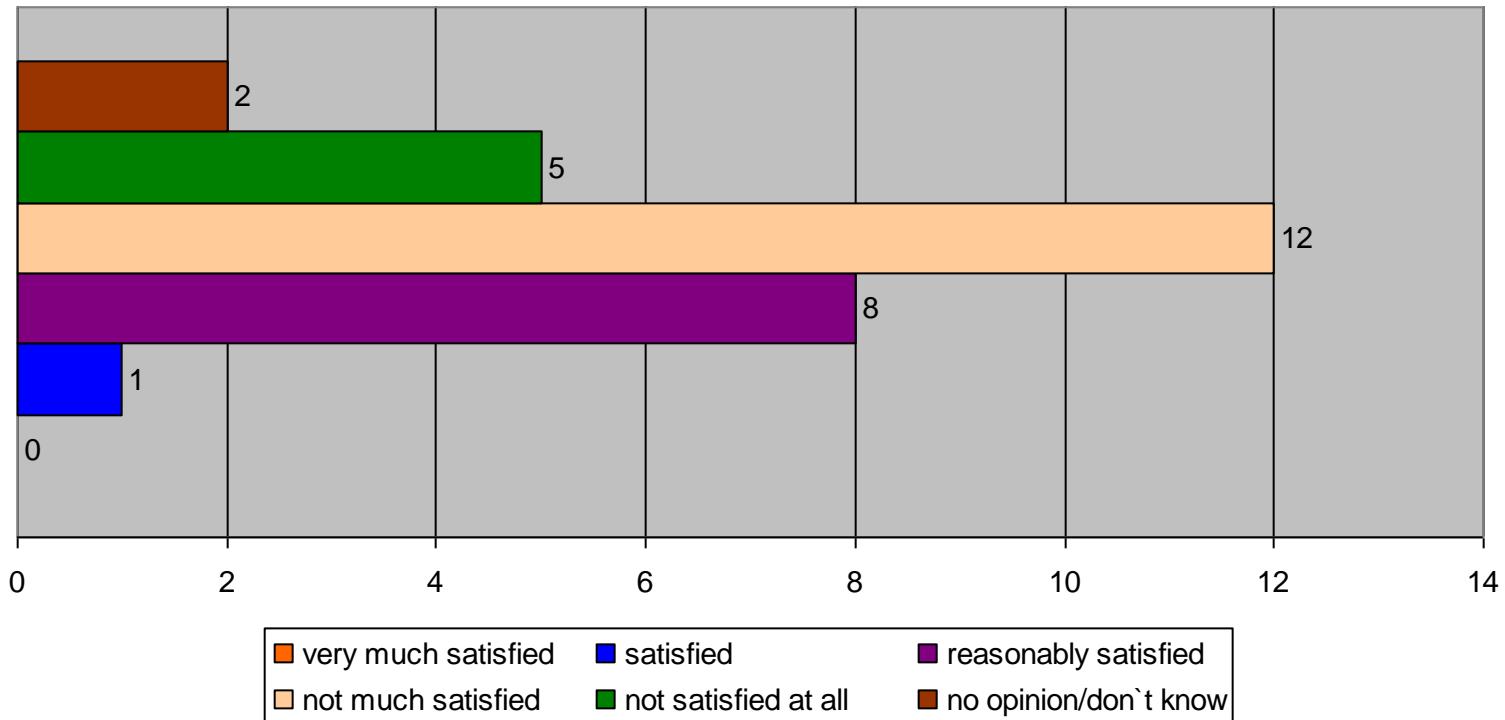

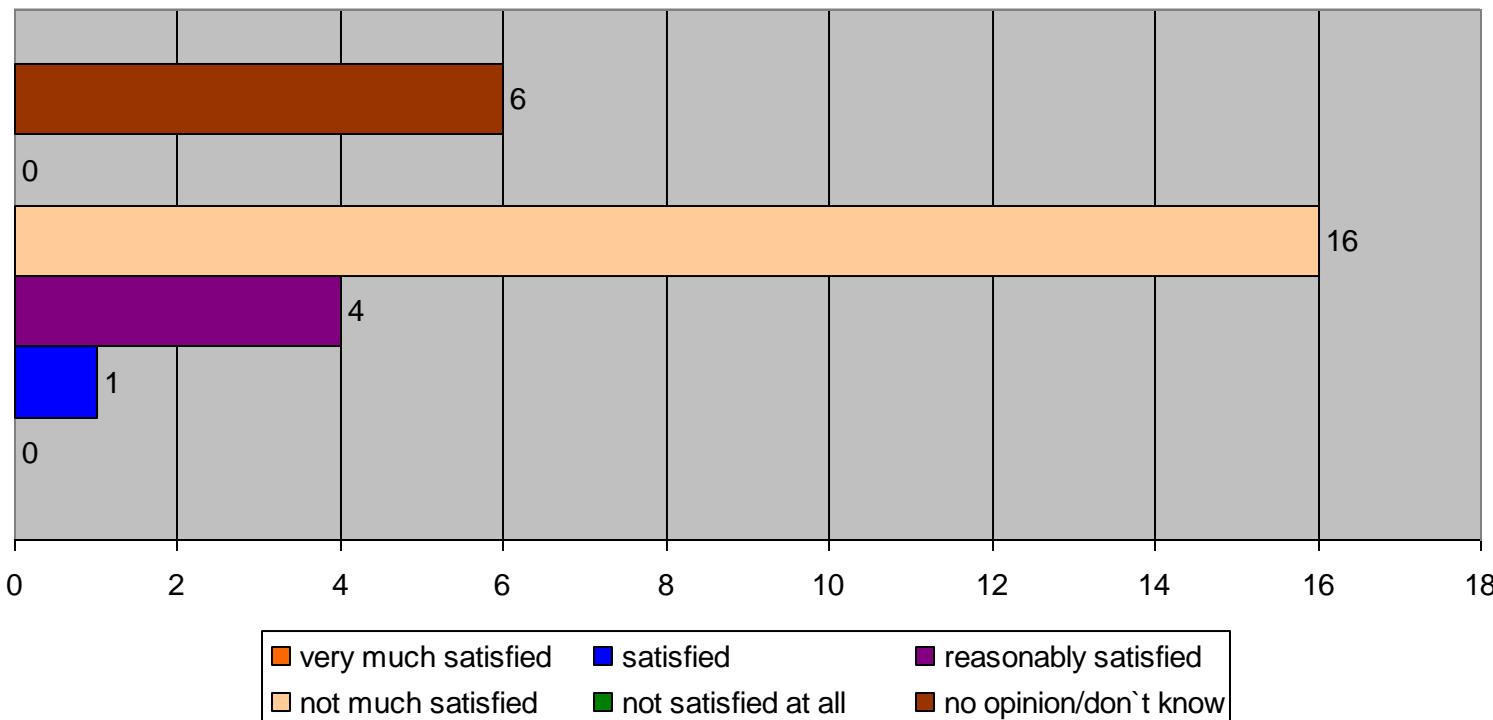
## Satisfaction with the marketing of the region as a World Heritage site as supporting USP / added value ...



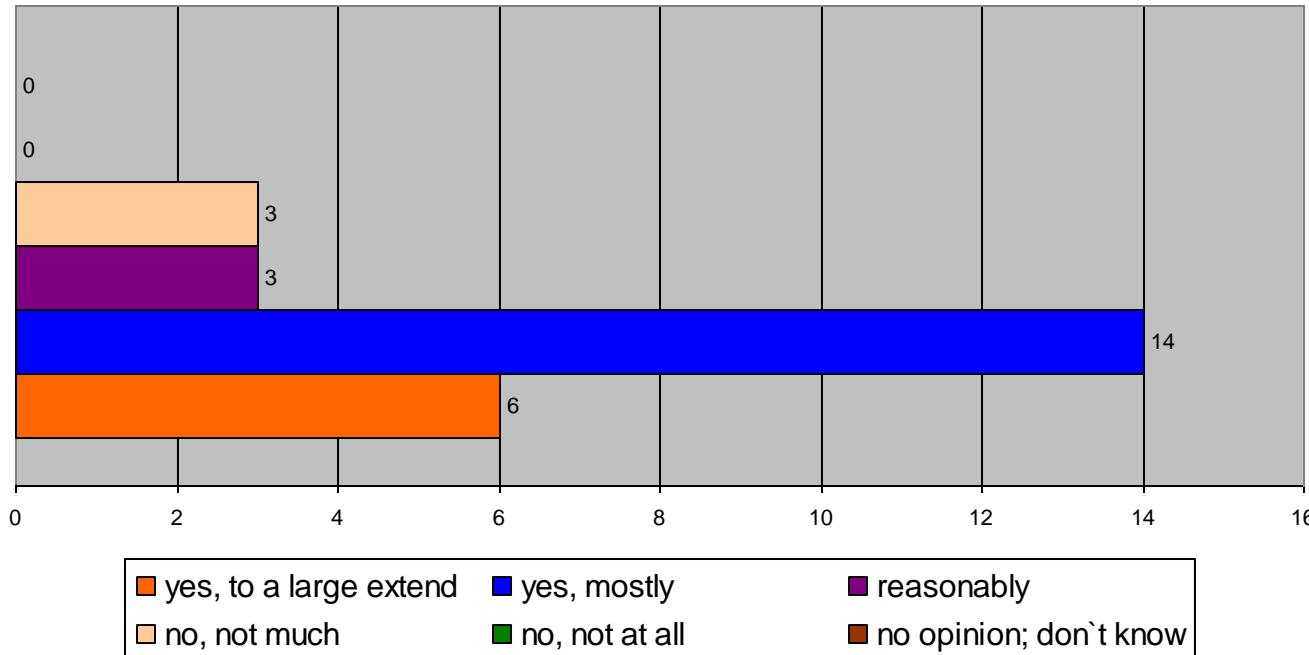
## Satisfaction with the information, communication and ongoing activities by the regional tourist boards and tourism marketing organisations related to the World Heritage status within the region ...



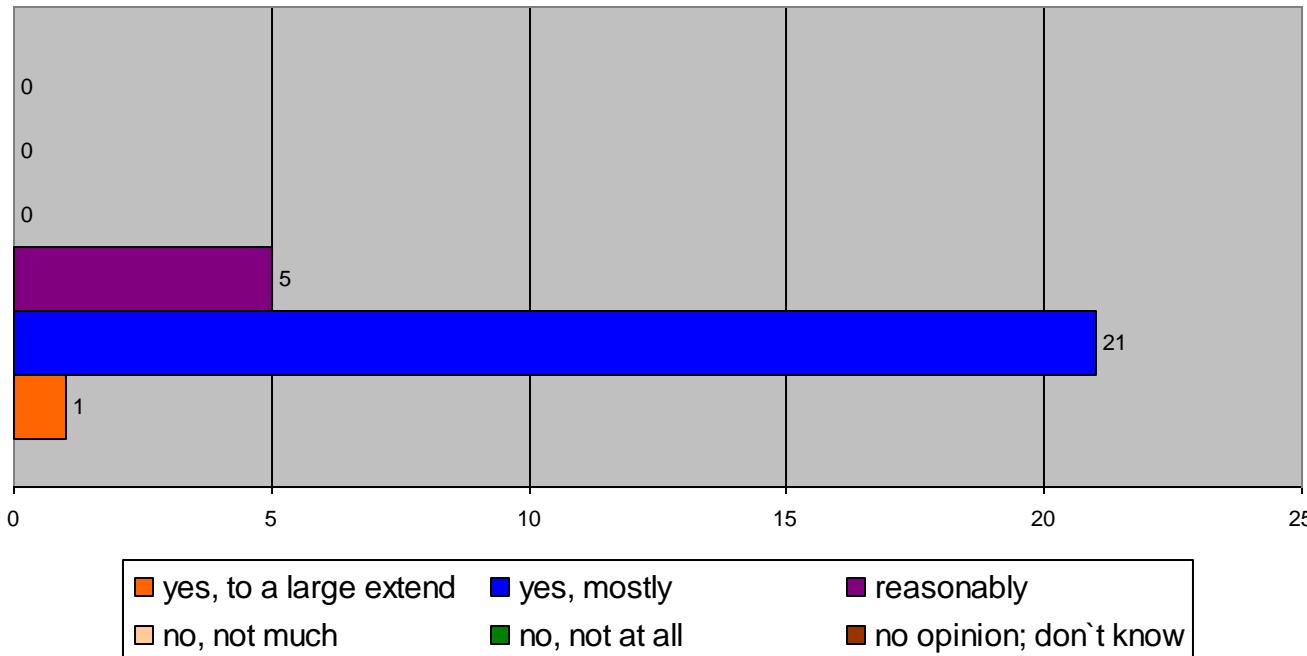
## Satisfaction with the information, communication and ongoing activities by protected area administrations related to the World Heritage status within the region ...

## Gaps / missing links concerning marketing and communication of the Wadden Sea ...

- Cooperation in the tourism industry is not organized very well – small businesses are very much operating on their own





## Views to offer about the marketing of and communication about the Wadden Sea ...

- Only the Sea side is designated as WHS, but for the public however the Waddensea, the islands and the mainland shoreline is one destination – it should be dealt within an integral way
- To promote the entire WHS Waddensea instead of just bits of it - the success of a destination on another island should not be seen as competition but complementary
- To take the German part of WHS and activities there as an example to orientate on and to learn from





## Views to offer about the marketing of and communication about the Wadden Sea ...

- Further improvement of information for visitors is desirable, including tourism and visitor centres, digital information and interpretation signs on sites
- More and updated information about tourism offers
- To use the WHS designation to promote on the international market as a special and sustainable destination
- More cooperation between entrepreneurs, transportation stakeholder, between islands and regions etc.

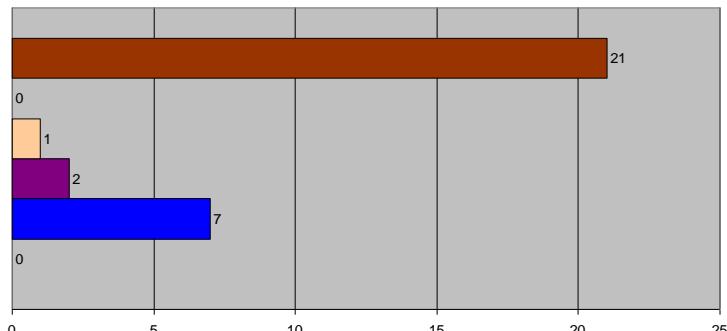

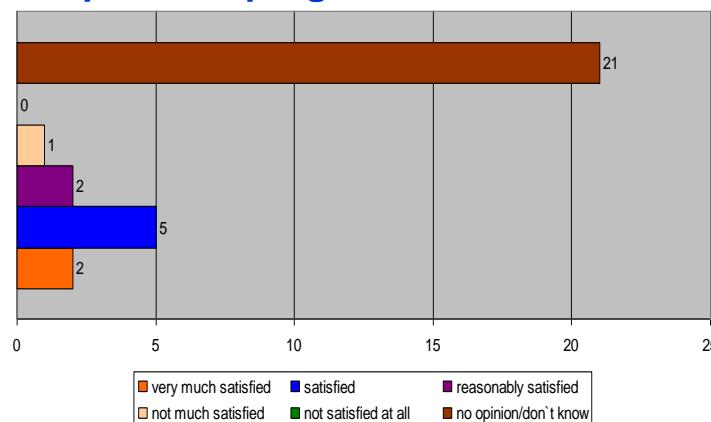

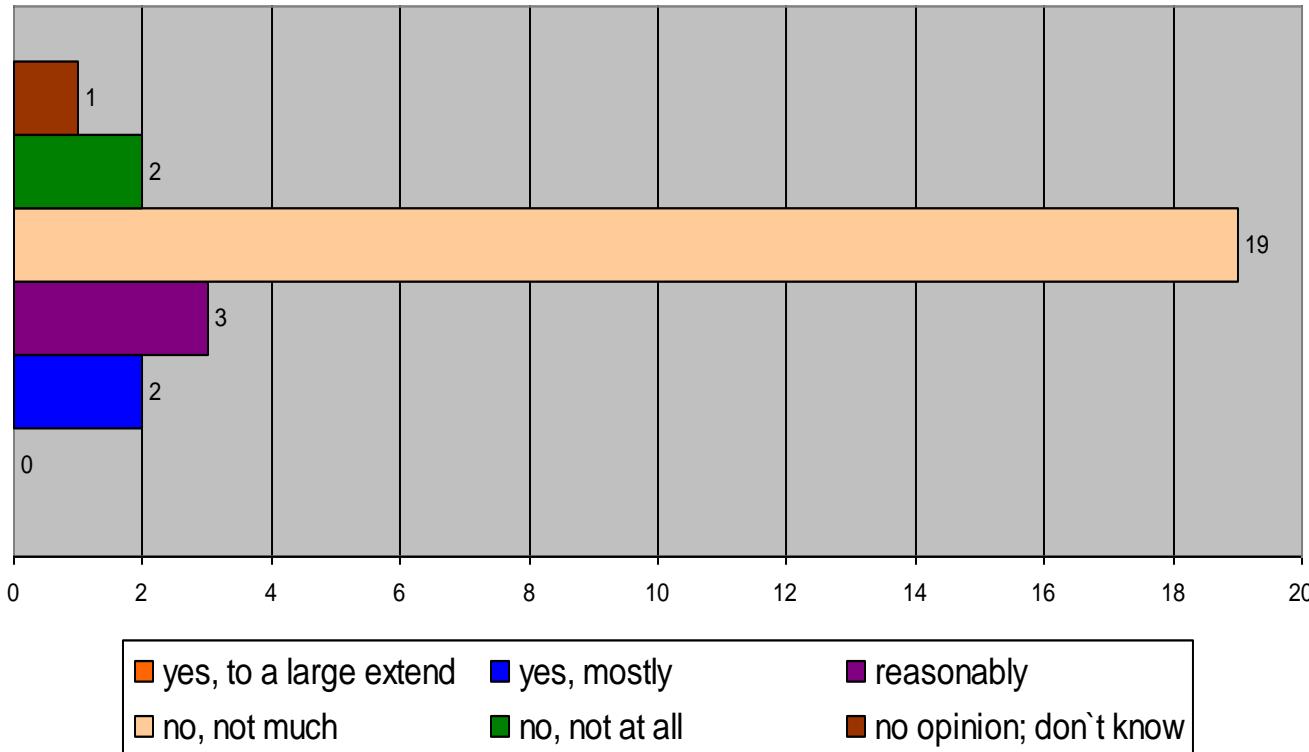

## Do the existing visitor information and edutainment offers contain the World Heritage as theme?

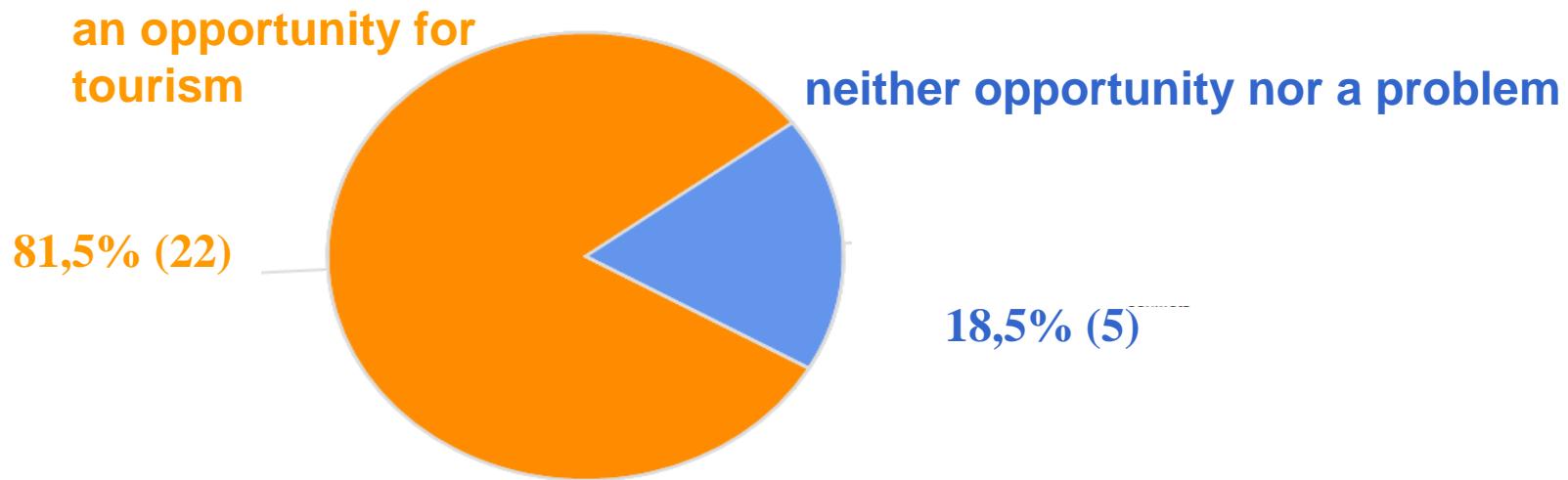

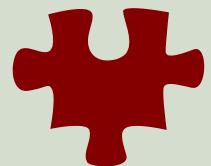

# Gaps and action



- **Promotion of whole WHS and to take Germany as best practice**
- **Demand for more cooperation between all kinds of stakeholder**
- **Improvement of visitor information (tourisms and visitor centres, digital information, interpretations signs on sites etc.)**
- **Much more information/market research on visitor demand and tourism offers**
- **To find a balance between conservation/protection and tourism possibilities/offers – create interesting offers on the less frequented mainland to avoid environmental degradation**
- **Sustainable use of produce (local products)**
- **Quality labels /certification could be useful, but have to be better communicated to the general public**
